

GRABBIT – COVID 19 SAFETY KITS CAMPAIGN

TERMS AND CONDITIONS

The Grabbit – Covid 19 Safety Kits Campaign (“**Campaign**”) is organized by Presto Pay Sdn Bhd [Registration No. 200701037789 (795818-U)] (“**Organiser**”).

A. ABOUT THE CAMPAIGN

1. The Campaign is open to Presto App users. The Campaign will begin on 20th March 2020 and end at on 26th March 2020 (“**Campaign Period**”).
2. By participating in the Campaign, Participant has:
 - (a) read, understood and agreed to abide by and be bound by the terms and conditions of the Campaign including but not limited to all amendments, additions, replacements deletions and modifications thereto (“**Terms and Conditions**”) as may be made, amended, varied from time to time by the Organiser;
 - (b) read, understood and agreed that the Terms and Conditions of Presto Arcade shall be read together with the Terms and Conditions herein. In the event of any inconsistencies between the Terms and Conditions of Presto Arcade and Terms and Conditions herein, the Terms and Conditions herein shall prevail to the extent of such inconsistencies; and
 - (c) read, understood and agreed that the Campaign Period may be revised by the Organiser without any prior notification and reasons.

B. CAMPAIGN MECHANISM AND REWARD

3. The Participant will be given the control of a virtual crane or claw machine in the Presto Arcade to pick up prizes of surgical face mask or hand sanitizer as shown in the Presto Arcade.
4. The Participant successfully picked up prizes of surgical face mask or hand sanitizer using the crane or claw machine in the Presto Arcade will be entitled to a Reward of 5 pieces of surgical face mask or 1 small bottle of hand sanitizer. Such Reward shall at all times be subject to availability.
5. The Organiser shall not be liable for any system glitches during the Campaign Period. Any system glitches during the Campaign Period shall be addressed as soon as possible and subject to any guidelines and regulations as prescribed by the relevant authorities from time to time including but not limited to the restricted movement order.

C. SHIPMENT OF REWARD

In respect of shipment of Reward within Peninsular Malaysia, the Reward will be shipped to the successful Participant within seven (7) working days from the date the Participant successfully picked up the Reward. In respect of shipment to East Malaysia, such shipment shall be subject to additional charges as advised by the Organiser and payable by the Participant.

The Participant agrees, accepts and acknowledge that any delivery of Reward shall be subject to any guidelines and regulations as prescribed by the relevant authorities from time to time including but not limited to the restricted movement order and the Organiser shall not be liable in whatsoever manner in respect of any unfulfilled delivery within the stipulated period.

8. To the fullest extent permitted by applicable laws, the Organiser offers no warranty or representation whatsoever, express, implied or statutory, in relation to the Campaign or Reward.
9. The Organiser shall at its sole discretion be entitled to disqualify any Participant without providing any notice or reason.
10. The Organiser may make any amendments, additions, replacements, deletions, variations and modifications to the Terms and Conditions from time to time without prior notice to you. All decisions made in relation to the Campaign by the Organiser shall be final, conclusive and binding.
11. The Organiser shall not be held liable for any losses, damages, costs, claims (including third party claims) and injuries whether directly or indirectly arising out of or as a result of any act, omission or negligence of the Organiser.

The Organiser shall not in any event be liable or responsible to the Participant and/or any third party for any costs, losses or damages whether arising directly or indirectly, resulting from loss of revenue, loss of profits, loss of business or goodwill, loss of opportunity, or any indirect, consequential, special, punitive or incidental loss of damages of any nature whatsoever in any circumstances.
